Shah stressed that the Narendra Modi government framed the new laws -- Bharatiya Nyaya Sanhita (BNS), the Bharatiya Nagarik Suraksha Sanhita (BNSS) the Bharatiya a Adhiniyam and the Bharatiya Sakshya Adhiniyam (BSA) -- to ensure that all rights of citizens are protected and no criminal goes unpunished. Addressing an event



marking one year of the rolling out of the three criminal laws, the BNS, BNSS and the BSA, Shah BNSS and the BSA, Shah said since all processes are online, nothing will be overlooked and justice will be delivered on time."These laws are going to transform the criminal justice system in the country significantly. I assure all the citizens of India that it will take a maximum of three years
