### Press Club of Jammu vs Dinesh Malhotra & Others Justice Koul directs parties maintain status quo until next hearing

The Press Club of Jammu filed a petition through Advocate through Advocate Inderjeet Gupta, against Dinesh Malhotra and oth-Dinesh Malhotra and others, with Advocate P.S.
Pamar, representing the respondents. The case was heard by Justice Vinod Chatterji Koul in the Jammu & Kashmir High Court. During the pro-

ceedings, the caveat filed by the respondents was discharged, as Advocate P.S. Pamar, appeared on their behalf. The court then proceeded to issue a then proceeded to issue a Notice in the matter. Advocate P.S. Pamar accepted the notice on behalf of the respondents and requested a one-week extension to file a reply, which was granted by the which was granted by the

Owner of residential plot 328/4,Ward-50, Channi Himmat Colony after highlighting of violated construction making land use change in public domain through print media installs back window towards front side of kitchen removed earlier but commercial hall on three floors are still intact covering porch area and not constructing open Verandah on Porch keeping windows and small door besides keeping side entry to reach at first and 2nd floor without maintaining setbacks and completely changing both internal and external dimensions against approved residential site plan

After publishing of story dated 13-11-2024, the owner continued violated construction making land use change in the wrap of opaque sheet and installed back window towards front side of kitchen but rest of the violated construction is still intact. It is highly unfortunate that open land use change is going on but as on date JMC enforcement staff deployed in Ward -50 has not moved even an inch despite bringing the same into kind notice of Enforcement staff much to the agony of aggreed locals who have already strongly resented land use change openly and brazenly and as on date commercial construction heading towards final stage

As per drawing of approved site plan, the owner didn't construct kitchen towards left side porch right side, followed by living room drawing room then back of them two bed rooms with common toilet along with stairs inside as raised construction ought to be duplex residential house which was not constructed. Besides as per drawing, the owner was to construct open Verandah on both floors on porch area but not constructed by owner and infact constructed commercial halls on three floors

Notwithstanding this newspaper published a detailed story along with pictures dated 13-11-2024 that that JMC unmoved towards that JMC unmoved towards open construction of commercial hall on ground floor in place of sanctioned kitchen by removing existing window and keeping provision for shutter and shop on porch area on residential plot 328/4 on main 60 ft road of Channi Himmat Colony in Ward-50 without mainstipping establishing services. without maintaining setbacks making open land use change keeping separate entry from porch absolutely contrary to approved residential site plan, JMC field staff has not taken any action against

owner. On the contrary , JMC enforcement staff very next day on 14-11-2024 guided owner to continue violated commercial construction commercial construction under wrap of opaque sheet to spare action from JMC and also to calm aggrieved people who were raising strong voice against open use of land use change from residential to commercial. As per the instructions and guidance of enforcement staff, owner for the time being again put win-dow towards front side of kitchen which was earlier removed to pave way for commercial hall but other than installing window back, the owner has maintained commercial hall without any partition in the back of





kitchen.

It deserves mentioning here that owner Surinder Kour wife of Charan Singh r/o Tali Morh, Miran Sahib r/o Tali Morh, Miran Sahib Jammu purchased a residen-tial plot 328/4 measuring 30x55 (1650 Sqff) on main 60 ft road of Channi Himmat colony in Ward-50 for resi-dential purposes. The owner accordingly got approved residential site plan from JMC vide No. 148/JMC/85/2023-24 dated 25-4-2023. As per approved site plan, the owner was allowed ground+ two was allowed ground+ two floors measuring 98.16( 1056 Sqft) each floor. The owner was duty bound to observe mandatory setbacks including front- 3.96 mtr (13 ft) and rear Cont. on Page 11
